

Your contract is with Charles Applewhaite Pro Tennis, registered address, Pen-Y-Cae, The Old Warren, Broughton Flintshire CH4 0EG. www.lamangatennis.com charlesapplewhaite@gmail.com

Within this contract Charles Applewhaite Pro Tennis is the provider of the Tennis Coaching Holiday. 'The Customer' is the individual paying for the provision of the tennis coaching holiday.

1. Tennis Coaching

The tennis courts will be provided by the La Manga Club.

The coaching /training/matchplay will include a minimum of 2 ½ hours tennis per morning for 5 days. The coach will be Charles Applewhaite Professional tennis coach. In the event of injury to the nominated coach a suitable replacement will be provided with the appropriate qualifications.

In the case of adverse weather conditions the coach will endeavour to acquire alternative facilities or change the scheduled times to accommodate this eventuality.

2. Holiday Location/Acomodation

The accommodation is at the luxury Los Olivos apartments in La Manga Club.

Accommodation .has been booked with SUN-HAT LTD ABTA No .L6737.

The apartments overlook the tennis courts and each has three twin bedrooms with two bathrooms, large open plan lounge and dining area, kitchen and large terrace with superb views.

Generally the apartments will accommodate four persons.

The holiday accommodation is subject to the terms and conditions on the Sunhat website. It is important that you read, understand and agree the terms and conditions for the provision of accommodation as stated by SUN-HAT Ltd prior to signing this contract.

3. Flights

The customer is responsible for the costs of all their own flight travel and transfers . The nearest airports are

SAN JAVIER AIRPORT MURCIA (30 minutes by car) and **ALICANTE AIRPORT** (90 minutes by car)

Airport transfers and self drive car rentals are available

4. Making a booking

Bookings made by an individual will be non-transferable. Bookings made must be by an adult (over 18 yrs old). Upon booking with Charles Applewhaite Pro Tennis a deposit of £150 will be required. Deposits paid are non-refundable & non-transferable to later bookings.

The balance of the costs to be paid prior to 12 weeks before the first day of the tennis holiday.

Individuals travelling accept that Charles Applewhaite Pro Tennis will manage all bookings for Coaching, court bookings and Accommodation only.

Charles Applewhaite Pro Tennis reserves the right to change location of the Tennis holiday and also accommodation (if circumstances warrant) All arrangements will be undertaken by Charles Applewhaite Pro Tennis to ensure the least disruption is caused to 'The Customer and to the tennis holiday.

On acceptance of this contract, customers travelling accept it is **the responsibility of the individual 'The Customer' and not Charles Applewhaite Pro Tennis to organise flights.**

5. Payments and Cancellation

Deposits are used as part payment of the full holiday price total. Deposits are non-refundable and non-transferable to other customers travelling on later bookings through Charles Applewhaite Pro Tennis. All monies paid as 'The Deposit' will be forfeited upon cancellation by the customer.

All remaining monies to be paid by 'The Customer' to the full cost of the holiday with Charles Applewhaite Pro Tennis will be refunded upon full written confirmation at least 12 weeks prior to the date of travel.

If cancellation is made after 12 weeks prior to the date of travel by 'The Customer', all monies including deposit will be non-refundable. If Charles Applewhaite Pro Tennis requires to cancel 'The Tennis Coaching part of the holiday, no reimbursement will be covered for loss of monies incurred by 'the customer' on accommodation, flights or any other alternative arrangements made for travel.

6. Travel and Insurance.

Charles Applewhaite Pro Tennis will ensure that all relevant notification is given to 'The Customer' of the required travelling documents for the holiday. Charles Applewhaite will not reimburse 'The Customer' of any monies paid for the holiday booked if travel arrangements are not able to be organised by 'The Customer' for their own flights.

6. Travel and Insurance (Cont)

All customers are required to have in place appropriate travel insurance that could provide effective cover to and for the client in the case of any of the following possible circumstances,--

- Flight delays/cancellations—
- Personal illness /accident/injury (before and during the tennis holiday) –
- Damage to accommodation etc —
- Tennis court damage
- Accident to the coach /Force Majeur.

Charles Applewhaite Pro Tennis reserves the right to cancel if appropriate travel insurance documentation can't be shown prior to the day of travel. Upon being unable to show appropriate insurances prior to travel, Charles Applewhaite Pro Tennis will not be responsible for the loss of monies incurred by 'The Customer' by the refusal of Coaching and no refund of 'the full monies' paid for the holiday will be given.

7. Health and Safety

Charles Applewhaite Pro Tennis can refuse the right to coach 'The Customer' if Charles Applewhaite Pro Tennis feels there are reasonable grounds to refuse coaching, this may include – intoxication, health issues or for Health & Safety reasons etc.. Charles Applewhaite Pro Tennis accepts no responsibility for injury, illness, etc to participants whilst being coached by Charles Applewhaite.

Charles Applewhaite Pro Tennis has 10 million pounds public liability insurance cover.

By booking with Charles Applewhaite Pro Tennis & upon payment of deposits to Charles Applewhaite Pro Tennis 'The Customer' is accepting the Terms & Conditions here stated .
